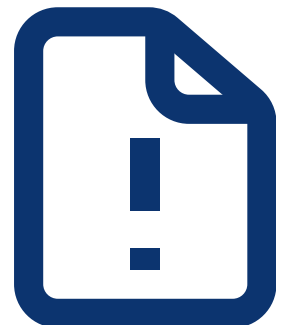


ANTI CORRUPTION
